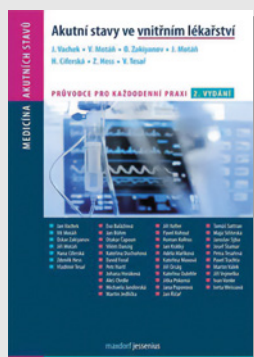

Příručka praktické medicíny určená především mladým lékařům, napsaná kolektivem internistů se zkušenostmi zároveň jak z fakultních pracovišť, tak i z menších nemocnic a z terénní praxe. Cílem publikace je poskytnout rychlou odpověď na nejčastější akutní klinické problémy, nejen v oblasti vnitřního lékařství, ale i v souvisejících oborech, jako je např. neurologie, psychiatrie. Kniha tak vychází vstříc rovněž aktuálním potřebám internistů na příjmových ambulancích, kde je třeba řadu akutních stavů skutečně řešit a ne je jen odeslat.

Snahou autorů bylo vytvořit příručku, jakou by si sami byli přáli mít k dispozici v době, kdy nastoupili do zaměstnání. Spoluautorem nebo recenzentem každé kapitoly je odborník specializující se na danou problematiku. V současnosti jde o jedinou aktuální publikaci svého druhu na domácím knižním trhu.
