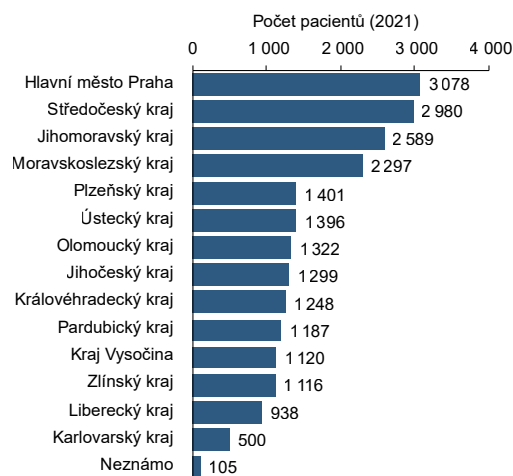

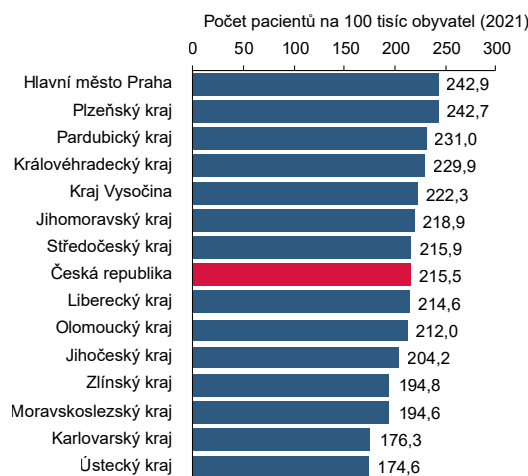
Senzory dle kraje bydliště v roce 2021
